What is Poland's energy storage subsidy program? From ESS News Following a public consultation launched in July, the Polish Ministry of Climate and Environment has finalized its energy storage subsidy program which aims to support the deployment of more than 5 GWh of energy storage in the country. The new regulation was published in the Journal of Laws of the Republic of Poland on March 7. How much money does Poland spend on battery energy storage?
