5 Support Myths Solar Companies Won't Tell You

Myth #1: "24/7 support means immediate fixes"

Reality? Most response times average 72 hours during peak seasons. That's like waiting for a refrigerator repairman during a heatwave - frustrating and potentially dangerous.

The Maintenance Paradox

Ironically, the better your system performs, the faster your warranty terms might depreciate. High-efficiency panels often have stricter degradation clauses. It's like punishing a car for getting good gas mileage!

Here's a pro tip: Always check the "end-of-term" coverage details. If your 25-year warranty only guarantees 80% output at expiration, that missing 20% could cost you \$1,200+ in lost energy savings.
