Notices are submitted through the Norwegian database (Doffin) and then forwarded to the EU's Tender Electronic Daily (TED) database. For procurements under national rules, only publication in Doffin is required. What happens if a contract is pending in Norway?Tenderers can seek injunctions to prevent contract signing while disputes are pending. Damages may cover either lost profits (if the tenderer can prove they would have won the contract) or bid costs.
