What is a turnkey EPC contract?The key thing to note is that with a turnkey EPC contract, you can't get just a piece of the package. Why should you sign an EPC contract with a solar provider?When you sign an EPC contract with a solar provider, that company alone is responsible for developing and installing your entire solar system, from the design to final construction. They procure all the equipment and materials necessary to build your solar installation. They also serve as a single point of contact for you, the customer. What does a solar EPC contractor do?To aid in their ability to deliver turnkey projects, solar EPC contractors usually offer every customer a very similar set of services. Most contracts include a simple solar system design and basic engineering services, as well as the materials and labor required to install and commission that system. Do EPC contracts impose PLDs?Most, however, do not impose PLDs. EPC Contracts impose PLDs because the achievement of the performance guarantees has a significant impact on the ultimate success of a project. Similarly, it is important the solar facility commences operation on time given the liability the Project Company will have under other project agreements. What is a performance specification in an EPC contract?Performance specification: Unlike a traditional construction contract, an EPC Contract usually contains a performance specification. The performance specification details the performance criteria that the Contractor must meet. However, it does not dictate how they must be met. This is left to the Contractor to determine.
