Unlike domestic contractors, foreign contractors must be granted a construction operation license (in Vietnamese: gi?y phép ho?t ??ng xây d?ng) as a key license for their construction activities in Vietnam. What is an EPC contract? EPC stands for Engineering, Procurement, and Construction. An EPC contract is a type of construction contract where the contractor takes responsibility for the engineering, procurement, and construction activities of a construction project and delivers a completed final project to the employer or owner. Which EPC activities require an operational office?
